

## BPXmas 2025 Terms & Conditions

### 1. Overview

When your business trading account purchases qualifying products from participating manufacturers during **BPXmas 2025**, your account will receive a free manufacturer gift and a BPX gift. By participating, you agree to these Terms and Conditions.

### 2. Promotion Dates

The offer runs throughout **December 2025**, starting on 1 December at 00:00 and ending on 31 December at 23:59.

### 3. Eligibility

The promotion is open to **BPX trading account holders in the UK and Ireland**.

BPX employees and partners are not eligible to participate.

### 4. How Gifts Work

- Gifts are awarded **per business account**, not per individual contact.
- Each account may receive:
  - **One gift per participating manufacturer**, regardless of the number of qualifying orders or contacts.
  - **One BPX gift per account** during BPXmas 2025.
- Gifts are sent to the **delivery address associated with the trading account**.
- Gifts are subject to availability and will be distributed on a **first-come, first-served basis**.
- Gifts cannot be exchanged for cash or store credit.
- BPX reserves the right to substitute gifts of **equal or greater value** if necessary.

### 5. Training Codes & Vouchers

- Training codes are limited to **one per business account** and will be validated upon redemption.
- The **50% off** and **10% off** vouchers cannot be combined; each must be applied to a separate booking.
- Training courses must take place during **2026**.
- All bookings are subject to course availability.
- Vouchers are **non-transferable** and can only be redeemed by the business account.

## 6. Prize Draws

- Certain gifts or offers may include entry into a prize draw.
- Prize draws will take place in **January 2026**.
- Each account can enter **once per qualifying promotion** unless stated otherwise.
- Winners will be contacted by **Friday, 16 January 2026**.
- If a winner cannot be reached within 14 days, a new winner may be selected.
- Prize draw entries are awarded to the business account, not individual employees.

## 7. Marketing & Communications

We may contact your business account about BPXmas 2025, especially if your account has previously purchased qualifying products.

You can opt out of marketing communications at any time.

## 8. Data Privacy

We process business account data in accordance with our **Privacy Policy**, including information needed to:

- Send gifts,
- Contact prize draw winners, and
- Report on promotion performance.

## 9. Responsibility

BPX is not responsible for:

- Delays or losses caused by third-party couriers,
- Events beyond our control, or
- Any loss or damage resulting from participation.

Your legal rights remain unaffected.

BPX reserves the right to modify, suspend, or end BPXmas 2025 at any time. Significant changes will be communicated to affected business accounts.
